

**Analyzing Arguments in the Same-Sex Marriage Debate**

**Introduction**

In the current debate raging in many states, advocates of same-sex marriage brandish slogans such as freedom, anti-discrimination, equality before the law, the appeal of love, etc., and see themselves as champions of America's best values. Meanwhile they picture their opponents as religious bigots and out-dated, "pathetically imposing their subjective thinking on others." But is it true that these advocates are free from subjective thinking and that those who oppose same-sex marriage can only appeal to the Bible<sup>1</sup> and tradition? It is high time that we analyze the arguments of both sides objectively with reference to well-documented studies instead of merely making emotive appeals.

**Justice, Equal Protection and Non-discrimination for Same-sex Partnerships?**

One argument for same-sex marriage appeals to justice, equal protection, and non-discrimination for all. To adherents of this position, there is no moral ground to restrict marriage to the union between a man and a woman and to deny it to same-sex partners.<sup>2</sup>

However, on close observation, this argument lacks cogency. For in most areas of life, equality is in terms of potentiality only, namely, as equal chances, while much depends on the nature of the matter being considered. Not all can qualify for a specific job; much depends on the requirements inherent in the job. Nobody would automatically label such restrictions as inequality or discrimination.<sup>3</sup> Thus for the success of the "equal protection argument" for same-sex marriage, one has to argue in addition that same-sex unions fulfill entirely the requirements of marriage traditionally understood.

Now traditionally, marriage has been understood to involve:

- (1) love expressed in sexual intercourse;
- (2) a covenant or contract for those concerned consenting to stay together for life;
- (3) between one man and one woman (not of the immediate family) with the potential for procreation;
- (4) with the potential for nurturance of children.

Because of the advantages of traditional marriage in securing the propagation and welfare of future generations, in most societies married persons have been given special privileges, e.g. medical insurance coverage for the spouse, inheritance of social security benefits at death, etc. For single persons without spouse and children, social security benefits would not accrue to their family, relatives, or friends on the point of their death, even though they have worked all their lives as hard as married persons.

With such an understanding, same-sex union that has no potential for producing children (except by a previous heterosexual marriage, adoption, or artificial insemination) is clearly different from traditional marriage.<sup>4</sup> To refuse to call it "marriage" is not discrimination, but perfectly acceptable, unless we are prepared to argue that single people (sexual orientation to celibacy) should not be discriminated against and should be given the same privileges as same sex partnerships; after all, singles can also adopt and single women can give birth by artificial insemination or by sexual intercourse.

Actually for the current advocates of same-sex marriage, equality in sexual orientation clearly is not their only concern, because in their redefinition of marriage, they have merely modified (3) above to read one man and another man, or one woman and another woman, and have kept (1) and (2) little changed. But if equality were their only concern, why continue the “discrimination” against incest? Why insist on marriage as one person with another person, and discriminate against polygamy and polyandry? Doubtless others have the sexual inclination for more than one partner at one time! Why discriminate against marrying with minors who consent? At present there is the North American Man-Boy Love Association (NAMBLA) that advocates man-boy love. Then, why insist on consent and not non-dissent? Why discriminate against marrying with a pet to obtain tax benefits? (It is alleged that Peter Singer, the protagonist for animal rights, does not object to sex with animals, so long as the animal is not eaten). If equality were the only criterion, any sexual inclination and object of marriage should be permitted. Also, why insist on life-long commitment? Why discriminate against short-term contracts of marriage? To argue for same-sex marriage on the basis of equality alone is thus inadequate and highly problematic: it will open the lid of the Pandora Box; if its logic is applied consistently, this will lead to moral decay and social chaos.<sup>5</sup>

### **Love, Commitment and the Ordinary Human Person in Same-Sex Partnerships?**

In fact, even though the radical gay agenda aims eventually to revamp the marriage institution to allow for all kinds of living arrangements with no consideration for their effects on society,<sup>6</sup> same-sex marriage proponents at the present stage emphasize the love and commitment between same sex couples, to prove that, other than the homosexual aspect, their unions are no different from traditional marriages.<sup>7</sup> In short the argument of equality is not about sexual orientation alone, but also about the quality of the relationship, i.e. loving commitment, as no different from heterosexual marriages.

But is same-sex partnership really equivalent to traditional marriage? Now it is inadequate to point to isolated instances of stable partnership among homosexuals. Undoubtedly such examples may and do exist.<sup>8</sup> Nor can it be denied that divorce is rampant in heterosexual marriages. What is more important is, rather, the general pattern or majority cases. Here the answer is clear that homosexual partnerships are generally very much different from heterosexual marriages. 1) Many surveys show the much shorter duration of same sex partnerships, lasting a few years only on average, whereas a survey showed that 67% of heterosexual marriages lasted over 10 years, and 50% over 20 years.<sup>9</sup> 2) Whereas at least 75% of husbands are faithful to their wives, among homosexual (especially gay) unions, “extra-marital” sex is very prevalent and less than 25% are faithful to their partners.<sup>10</sup> Moreover, in gay unions, there is a much higher number of sexual partners (including strangers) involved in addition to the primary relationship.<sup>11</sup> 4) Same-sex partners engage in very different kinds of sexual activities (e.g. oral sex, anal sex, oral-anal “rimming”, fisting, sado-masochism, and even urinating on the sexual partner, and eating feces).<sup>12</sup>

This shows that for many homosexual couples, long term commitment is far less than heterosexual marriages. Moreover, even in long term partnerships, sex is divorced from

“love” and “commitment”: especially in the case of gays, extramarital outlets (in the words of homosexual author Sullivan<sup>13</sup>) are often numerous. Hence their partnership is different from the traditional understanding of monogamous marriage. Consequently if we say that homosexual partnerships exhibit the same kind of love and commitment, we are deceiving ourselves.

We also deceive ourselves if we think that marital disharmony is only prevalent in traditional marriages but not in same-sex unions. In a 1988 survey involving 6779 people, 4.9% men and 6.2% of women in traditional marriages reported oral disputes escalating into violent aggression, whereas in a survey of gays and lesbians at about the same time 46% reported using physical aggression for conflict resolution.<sup>14</sup> Thus statistics show that violence, physical and sexual abuse are much more frequent among same-sex partners than in traditional marriages. In addition to the greater frequency of violence, there is also greater severity of violence, sometimes resulting in death.<sup>15</sup>

In view of such facts, it is unreasonable to claim that same-sex unions are equivalent to traditional marriages. It is also ridiculous to claim that “legalizing same-sex unions would strengthen traditional marriages”.<sup>16</sup>

### **Freedom, Rights and Privacy for Same-Sex Partnerships?**

Granted the failure of the equality and love argument, what about other ideals of democratic society, such as freedom, rights, and privacy? If homosexuals are entitled to education, housing, and jobs as responsible individuals in society, why deny them the freedom and right to enjoy marriage with whomever they want regardless of the sex of their partner? After all, what two mature persons consent to do in private is no other people’s business, as the Lawrence Against Texas ruling has established.

However, this argument likewise cannot stand. For in theory, most people (whether libertarians or adherents of social contract theories) would agree that nobody has the freedom to harm or offend others. Consequently, no matter how much a government respects the freedom of individuals, it would legislate against people harming others. By “harm” here we simply refer to adverse effects (both immediate and long term) on physical and psychological health. In addition, no matter how much a government respects individual freedom, to a greater or lesser extent it would prohibit, or try to stop, people (especially minors and those unable to control their actions) harming themselves, or at least encourage people to take good care of themselves. For instance, as long-term smoking harms oneself and others, we have laws prohibiting smoking in many public places and against minors buying cigarettes; cigarette packs are also required to state warnings on health. Likewise consumption of alcohol and many drugs are regulated by the government. Thus in state legislation concerning same-sex partnerships, the question should not be whether there is infringement of the freedom and privacy of homosexuals, but rather whether there is sufficient evidence to indicate that the lifestyles of same-sex marriage is harmful for the individuals concerned, the children connected with them and for society as a whole. In addition, if certain lifestyles are harmful, how prevalent are they, and are they inevitably adopted by homosexuals?

Now, as mentioned earlier, same-sex couples *per se* cannot produce children. Thus, from the perspective of human propagation, same-sex unions should not be treated as equal to heterosexual marriages and granted the same material benefits, unless there is over population and drastic measures are needed to reduce the population.

Then in the above discussion on domestic violence, we have already seen evidence that same-sex couples may harm each other physically and psychologically much more than heterosexual couples. But the harm they do to each other and to society as a whole is far beyond this by virtue of their sexual proclivities. Thus owing to their habits of oral and anal sex, their frequency of intercourse, and their numerous sexual partners, there is a much higher incidence of sexually transmitted diseases, hepatitis, gay bowel syndrome, HIV, AIDS and anal cancer among gay men.<sup>17</sup> In fact steady relationships may make matters worse because of the false confidence of the persons concerned leading to unsafe sexual practices.<sup>18</sup> While lesbian couples are generally less promiscuous, they are likewise not immune from various diseases because of their sexual habits.<sup>19</sup> Since homosexuals are at greater risks from serious diseases, their average life span is shorter than that of heterosexuals by decades.<sup>20</sup> Moreover, it has been estimated that 10% of the accidental deaths among young men in San Francisco resulted from sadomasochistic sex.<sup>21</sup>

While physical diseases and early death are alarming, studies from various countries reveal that homosexuals also suffer from depression, suicide, psychiatric disorders and substance abuse at a much greater rate than heterosexuals.<sup>22</sup> Now psychologists and psychiatrists sympathetic to homosexuals generally blame this phenomenon on the stress experienced by homosexuals as a result of society's discrimination against them.<sup>23</sup> However, this phenomenon is also reported in the Netherlands which has been highly tolerant of homosexual behavior and was the first country to legalize same-sex marriage.<sup>24</sup> Thus it is inadequate to blame the psychiatric disorders on discrimination and homophobia. Furthermore, a study in Britain shows that heterosexuals likewise experience discrimination and violence in adolescence.<sup>25</sup>

In view of the diseases and problems engendered by the homosexual lifestyle, a far greater amount of tax payers' money has been spent by society on homosexuals out of proportion to their numbers. Endorsing same-sex marriage would not alleviate this financial drain. It will make matters even worse.

Nor is the problem only connected with adult individuals and tax payers' money.<sup>26</sup> The next generation is being victimized unwittingly. For one thing, many men and women have left their original heterosexual marriages to start same-sex unions,<sup>27</sup> undoubtedly causing much pain to the children of their former marriages. As same-sex unions are much more volatile, children reared in such families experience instability and difficulty in their sexual identity, contrary to the statements of advocates of same-sex marriages.<sup>28</sup> In fact, owing to the lack of sexual inhibition (so-called "sexual creativity and diversity") of some gays and lesbians and their wish to "recruit" a next generation of homosexuals, children in such settings may be molested by their step parents early in their lives<sup>29</sup> and turn out to be homosexuals or bisexuals later.<sup>30</sup> Even if spared such misfortunes, children

brought up by same-sex couples have been found to be less able to relate to people of the opposite sex of their care-takers.<sup>31</sup> This way there will be segregation and polarization of the two sexes to the great detriment of society as a whole. Conversely numerous social studies have shown that traditional two-parent families provide the best environment for children to grow up.<sup>32</sup>

In short, same-sex couples cause much harm to themselves, to the future generation, and to the majority of the society. What they do “in private” actually affects the public! Thus society should not just consider the freedom of choice of adult individuals but must strive to create by legislation where necessary an environment favorable to the healthy development of children. It is even unethical to help people create untraditional families that rear children.<sup>33</sup>

### **Compassion to Victims of Society?**

Another argument frequently raised by advocates of same-sex marriage is that homosexuals cannot help their sexual orientation as it is inborn, and they have been victims of homophobia just as people have suffered in the past due to the prejudice against interracial marriages. What is urged is compassion to fight for them as heirs and beneficiaries of the civil rights movement.

However, this argument is woefully misleading. Unlike race, homosexual orientation is not genetically determined. So far all the studies that purport to demonstrate a genetic basis for homosexuality have been found to be wanting.<sup>34</sup> Meanwhile there are cases after cases of people changing from a homosexual orientation to become heterosexuals.<sup>35</sup> So the analogy of prejudice against interracial marriage is irrelevant. Those who continue to use the analogy are either ignorant or deceptive.

Moreover, gays and lesbians are not victims in terms of social position and income as demonstrated by studies in the U.S.A., the Netherlands and Britain. In fact a number of studies have found that homosexuals often enjoy higher professional status.<sup>36</sup>

While we should respect and love all people irrespective of their sexual orientation, we must be aware of the agenda of homosexual activists out to change marriage as an institution. In the past they have interfered with the deliberations of psychiatrists<sup>37</sup> and today they try to perpetuate lies in the name of science (such as “homosexuality is inborn and unchangeable”),<sup>38</sup> infiltrate into policy-making bodies and use various tactics to achieve their agenda.<sup>39</sup>

### **Conclusion**

Concession to same-sex marriage is irrational when their logic is flawed. It is blind not to see that endorsement of same-sex marriage would lead society to go down a slippery slope ending in chaos. It is also irresponsible not to rein in the destructive lifestyle of homosexuals when there is so much evidence of the harm of homosexuality (even in steady relationships) to the people concerned, to future generations and to society as a whole. When government officials and Supreme Court judges actively promote same-sex marriage without consideration of the societal consequences of their actions, they are

inexcusable. When their subordinates comply with their irresponsible behaviors, they are equally reprehensible. As for the silent majority, this is not the time of laissez-faire, for inaction will spell the disintegration of society. Let all who are concerned unite to preserve traditional marriage! For Christians, let us remember that the complementarities of the sexes is God-ordained and good, while endorsing same-sex marriage is tantamount to rebellion against God. Nevertheless, let Christians also fall on their knees and pray for God's mercy on all those adversely affected by the homosexual movement!
